Organisation name/type of work carried out:

The Homecare Association is a member-led professional association, with over 2,300 homecare provider members across the UK. Our members encompass the diversity of providers in the market: from small to large; predominantly state-funded to predominantly private-pay funded; generalist to specialist; live-in services to visiting services and from start-ups to mature businesses. ### About our proposals

#### **Registration changes for social care managers**

1. Do you agree with our proposal that social care workers who don't hold the recognised qualifications but do have sufficient managerial experience and are

enrolled to complete the level 4 and level 5 qualification within 3 years of registering, can register to be a social care manager?



2. Do you have any other comments:

We believe that this would be beneficial compared to the current situation.

It is not clear from the document whether it is just the requirement for a Level 3 qualification that is removed. For example, could someone who has a Level 4 qualification (but not a Level 2 or 3 qualification) register? If not, does this kind of scenario also need to be considered?

#### Registration renewal for social care workers

3. Do you agree with our proposal that social care workers who were required to complete the level 2 or 3 qualification listed in the <u>qualification framework</u> within the first three-year period of registration, will now have up to six years (over two three-year periods of registration), to complete the qualification?



4. Do you have any other comments:

This change would be a positive step as completing the qualification within three years can be challenging for some workers, particularly where they work part-time; and given the pandemic related pressures over the last three years this has been exacerbated.

However, we also believe that this leaves a broader issue unresolved. That some of those working part-time or more casual work who make a vital contribution to the sector, don't see social care as their 'career'. They might be working alongside another job, study, care responsibilities or retirement, for example. Some of those in these roles in the sector may not wish to continue if they have to undertake a level 3 qualification as this would be an additional requirement that would make working in other sectors more attractive.

We believe that there could be an additional tier of registration which would allow people to take on certain types of role with basic induction training – allowing the more casual part of the workforce to contribute; whilst allowing those who do wish to undertake level 3 qualifications to take on the work that would benefit more from a level 3 skill level.
